Dear Ms. Timmel:

As you know from our previous conversations, I represent Roxanne Shook, Board Member for the McCreary County Board of Education. I have reviewed the Preliminary and Final Investigative Report to the Board of Education of McCreary County School District. I have also reviewed the response of the McCreary County Board of Education.

It is important that the OEA be aware that Mrs. Shook was <u>never</u> contacted in any manner by anyone to respond to the preliminary report of the OEA. Mrs. Shook states that the McCreary County Board did not at any time take formal action to approve the formal Response and did not meet with Mr. Owsley to supply responses as a Board at any time. It is the belief of Mrs. Shook that the only individuals responsible for the responses of the McCreary County Board of Education were Board Chair Brandon Kidd and Acting Superintendent Michael Cash, based on Mr. Owsley's response in an email sent to Mrs. Shook when she questioned how the "Boards" responses were developed and by whom. Mrs. Shook was not consulted in any manner in regard to the response that was made.

Mrs. Shook wishes to respond to the allegation against the McCreary County Board of Education as a whole and the responses supposedly given by the "Board":

Allegation: The McCreary County Board as a whole are violating KRS 160.290 by failing to use district resources for the promotion of public education and general health and welfare of the pupils in the district and by usurping the statutory authority of the superintendent pursuant to KRS 160.370 and KRS 160.390.

Response of the McCreary County Board: In its response to the Investigative Preliminary Report, the Board states that the enrollment at the Academy was 86 students instead of 34.

Response of Roxanne Shook: Mrs. Shook states that during the December 18, 2014 Board Meeting (Minutes attached hereto as Exhibit 1) a McCreary Central Academy Financial Feasibility Study (attached hereto as Exhibit 2) was produced to all members of the McCreary County Board and discussed. The Feasibility Study shows the enrollment trends for McCreary Central Academy ("MCA"). The Average Daily Attendance for MCA was never higher than 35.60 during the 2014-2015 review. This dialogue was due to the proposal to move the MCA from McCreary Central High School back to McCreary Middle School to which Mrs. Shook voted "Nay" because of the statutory language in KRS 160.550 which places a legal prohibition upon each individual school board member from voting for any expenditure which is in excess of the available revenue and income for the year. Superintendent Wright received a letter dated January 20, 2015 from Associate Commissioner Hiren Desai which was forwarded to all Board Members and discussed at the Board Meeting prior to the vote. (attached at Exhibit 3.)

Response of the McCreary County Board: In its response to the Investigative Preliminary Report, the Board states that it did not vote to end its agreement with the Job Corps and provides a copy of an email from the Job Corps director which was forwarded to the Board by Superintendent Wright. The email is dated February 2, 2015. It is from the Center Director stating that the Job Corps does not intend to renew its agreement with McCreary County Schools past June 30, 2015.

Response of Roxanne Shook: The Board, including Mrs. Shook, was not afforded an opportunity to have an open discussion or give consideration to the email dated April 16, 2015 from Superintendent Wright to Board Chair Brandon Kidd in regards to the offering of "open dialogue" between Pine Knot Job Corp and the McCreary County Board of Education with regard to the Pine Knot Career Institute. Board Chair Brandon Kidd never placed this on the agenda for consideration by the entire Board. Mrs. Shook further states that she voted "Nay" to the Tentative Budget at the April 28, 2015 Board Meeting (see attached Exhibit 4). When discussion occurred regarding the budget, Mr. Kidd's response was that he did not believe that PKCI was generating revenue, despite the December 2014 email from Superintendent Wright to the Board Members discussing the success of the program; each Board Member also received the attached packet (attached hereto as Exhibit 4) with information regarding the revenue, expense, and profit of the Pine Knot Career Institute. Pine Knot Career Institute was abolished (see line item no. 6 attached exhibit 5) in the Tentative Budget. In a subsequent email (see attached exhibit 6) from Interim Superintendent Aaron Anderson, dated May 19, 2015 to all Board Members, he advised the Board that he was searching for ways to prepare to offset the loss of income from the Pine Knot Career Institute. Mrs. Shook states, if Pine Knot Career Institute was not generating income why was Mr. Anderson searching for ways to offset this loss. She also states, that Pine Knot Career Institute was a mutually beneficial program not only for the school system and for Pine Knot Career Institute/Pine Knot Job Corp itself, but for the community as a whole wherein the Pine Knot Job Corps has been and continues to be a contributing entity to this county by providing volunteer services such as clean up on our roads, construction services, money spent by employees and residents and by employing members of this community.

Response of the McCreary County Board: In its response to the Investigative Preliminary Report, the Board states that the funds approved in the budget for the Juvenile Drug Court Program were for the salary of a district employee. The Board concedes that the individual does

perform duties related to the Juvenile Drug Court Program but that her employment by the district is as a counselor.

Response of Roxanne Shook: Mrs. Shook states that she voted "Nay" to the Tentative Budget on April 28, 2015 (see attached Exhibit 3) as well as "Nay" to the Relocation of McCreary Preschool to Pine Knot Primary School and Whitley City Elementary School. This is the same budget which included the salary of this district employee for the duties related to the Juvenile Drug Court Program.

Response of the McCreary County Board: In its response to the Investigative Preliminary Report, the Board states that OEA reached the conclusion that the Board made decisions at the expense of student achievement based on "highly suspect and anonymous" interviews.

Response of Roxanne Shook: Mrs. Shook states that the board was informed by email dated October 6, 2014 regarding the test scores released October 2014 that all schools were progressing with the exception of Whitley City Elementary School. Mrs. Shook further states that videos of the Board Meetings were made during this time and OEA can view certain Board Members repeatedly claiming that the McCreary County schools were not progressing, despite Superintendent Wright informing them of the positive progress of the district.

Mrs. Shook further states that she has tried to the best of her ability, based on information given to her to abide by KRS 160.290 and has always voted in accordance with the statutes that guide her authority as a Board Member for the McCreary County Board of Education. Mrs. Shook states that she is currently and continues to be prevented from seeing and participating in some or certain correspondence and dialogue related to certain issues that come before the McCreary County Board of Education, as evidenced by the fact that no formal Board Meeting was called by Chairman Brandon Kidd in conjunction with legal counsel to formulate responses to OEA's Investigative Report by all members of the McCreary County Board of Education. Mrs. Shook has given thoughtful consideration into these responses and she appreciates your time and considerations in this matter.

McCreary Central Academy Financial Feasibility Study Transition from MCHS to MCMS 2014-2015

Based on the 4th month attendance data, the McCreary Central Academy currently has 35 students enrolled in the program. The average daily attendance (ADA) for the McCreary Central Academy is 31.19. The 2014-2015 budgeted revenues were based upon the prior year end of year adjusted average daily attendance (AADA) of 29.11. According to the prior year end of year AADA, the McCreary Central Academy generates approximately \$167,004 (29.11 x \$5,737 per pupil amount based upon 2014-2015 Final SEEK Adjusted Calculation). Below is a comparison of the ADA and enrollment from June 30, 2014 to December 1, 2014:

The budgeted expenses for the McCreary Central Academy consist of salary, fringe and operating expenses. The salary and fringe allocation is based upon the staffing allocation ratio of 22 students to 1 classroom instructor. According to the average enrollment of 37 students, the staffing allocation for the program is 1.68 or 2 full-time classroom instructors. (*Please note: the staffing allocation for the McCreary Central Academy is lower than any other school within the district.*) Of the total number of students, 6 students are expected to graduate at the end of the 2014-2015 school. If the number of students expected to graduate is deducted from the total number of students and no additional students are transferred into the program, the staffing allocation for 2015-2016 is projected to be 1.40 or 1 full-time classroom instructor.

The McCreary Central Academy currently staffs the following at its current location: 2 full-time regular education classroom instructors, 1 part-time special education classroom instructor, 1 full-time drug court counselor, and 1 full-time instructional assistant. (*Please note: the salary and fringe costs for the full-time drug court counselor and full-time instructional assistant are paid from local and state grants, respectively.*) The total costs to the General Fund for salary and fringe is currently \$141,223.

If the McCreary Central Academy is moved to the McCreary County Middle School, the General Fund would incur additional salary and fringe cost. The administrative cost for the full-time principal salary and fringe is \$85,472. (*Please note: the salary and fringe for the administrative cost has already been budgeted for the 2014-2015; however, the administrative cost for 2015-2016 of \$88,907 will be charged to the General Fund.*) Dependent upon the needs of students with special needs, the part-time special education classroom instructor may need to be increased to full-time which will cost an additional \$29,146 to the General Fund for 2014-2015 for McCreary Central Academy,

which, in turn will leave a part-time vacancy at McCreary Central High School. Pending the continuation of McCreary Central Academy students participating in Career and Technical courses at McCreary Central High School, there will be a need for transportation. The transportation costs for a mid-day bus driver with no prior years of experience is \$9,359. The grand total salary and fringe costs of moving the McCreary Central Academy to McCreary County Middle School is \$123,977. (Please note: the cost of the part-time vacancy at McCreary Central High School as a result of need for additional special education staff is not reflected in the grand total salary and fringe cost.)

The McCreary Central Academy is allocated \$5,363 for fiscal year 2014-2015 operating expenses. The allocation is based upon the SBDM Section 6 Instructional Materials calculation in which the prior year end of year ADA for 2013 was multiplied by the amount per pupil.

If the McCreary Central Academy is moved to McCreary County Middle School, the General Fund would potentially incur the following operating costs during 2014-2015:

Technology Equipment \$26,000¹

Textbooks \$9,000²

The grand total operating costs of moving the McCreary Central Academy to McCreary County Middle School is approximately \$35,000. (*Please note: there will be additional unknown cost identified throughout the transitioning process that is not reflected in the total operating costs.*)

The grand total salary, fringe and operating costs to the General Fund for moving McCreary Central Academy to McCreary County Middle School is projected to be \$158,977 for fiscal year 2014-2015. The reoccurring staff and operating costs for the upcoming school year 2015-2016 will be reevaluated and presented in future budgets presented to the Board.

¹ Based upon 40 workstations at the average cost of \$650 per workstation.

² Based upon \$75 per student multiplied by each content area for a total of 40 students.

RE: Clarification on KRS 160.550

Dear Superintendent Wright:

This is in response to your request for clarification on the applicability of KRS 160.550 to certain actions taken at a meeting of the local school board on January 8, 2015. You have provided me with documents relative to these actions and the information herein is based on that documentation.

As the provided board minutes demonstrate, the McCreary County Board of Education took action at this meeting to abolish the staffing allocation at the McCreary County Academy and increase current staffing levels, by adding three additional full-time teachers, increasing a part-time teaching position to a full-time position, and adding a full-time secretary position for the Academy.

As noted by the district finance officer, and reflected in the documents shared with the board at its January 8, 2015 meeting prior to their vote to increase staffing, staffing these additional positions will constitute an expenditure of funds in excess of this school year's income and revenues for the district. The documents demonstrate that the present members of the local board voted at that meeting in favor of increasing the staffing level of the district, after being informed of these concerns.

KRS 160.550 places a legal prohibition upon each individual school board member from voting for an expenditure which is in excess of the available revenue and income for the year, as shown by the budget adopted by the local board and approved by the Kentucky Board of Education (KBE). This statute also prohibits a superintendent from recommending to the board such expenditure. My understanding from reviewing the board minutes is that the district already has a current projected deficit of \$36,000 for this year, which needs to be addressed. In addition, the proposed changes to the staffing levels outlined above will increase this deficit significantly and cause the school district's general fund balance to drop below the 2% minimum reserve requirement in KRS 160.470(6)(a), with this action of dipping into the contingency fund putting the district precariously close to a true negative balance.

If this is accurate, the Kentucky Department of Education (KDE) would advise that caution is warranted, before proceeding in this manner. As you correctly stated and as noted in the board minutes, district expenditures

cannot exceed revenues. The consequences under KRS 160.550 for knowingly incurring expenditures which exceed revenue are severe. KRS 160.550(2) allows the commissioner to take over fiscal management of a district's finances if such actions occur and are certified to the KBE. In addition, KRS 160.550(4) imposes personal liability upon the superintendent and each board member who knowingly act in violation of its prohibitions. Moreover, in a situation triggering KRS 160.550, KRS 156.132 may also apply (removal for misconduct). Finally, KRS 157.410 only permits the commissioner to issue payments of any funds (including SEEK) to districts, when the districts have fully complied with school laws under the jurisdiction of the KBE.

With all this in mind, I would urge that the district only incur obligations and expenditures for which adequate revenue and income is available. I would also advise that the district proceed with caution in planning a budget for the upcoming fiscal year, because revenue will be extremely tight, given the 2% salary mandate and other factors.

Unfortunately we have over 200 missing forms. That is potentially over \$100,000.00 that we are not taking advantage of for our kids (probably much more than that when you consider Title I funding and other areas that are not as easy to calculate).

Here's the deal. We have a big problem. It doesn't matter how it happened, but we have to fix it....like yesterday.

Ethink everyone is very aware that shortages in funding is an issue all over the state. However, we can't complain about shortfalls when we are not taking advantage of funds that can easily be claimed with a little bit of work.

We will begin running this report daily (just like an attendance report) until we have all of these taken care of. We will also begin meeting monthly on ways we can improve this process and how we handle transfers in throughout the school year as well as changes in income that can occur with families.

I have no doubt we will have this process working like a fine oiled machine before school goes out. That way we will start the year next year with a better handle on the situation.

Pine Knot Career Institute 2014-2015

Revenue:

The McCreary County Board of Education receives SEEK funding based upon the prior year end of year AADA plus any growth in August and January. (If no growth occurs during the month of August, then no growth is calculated or funded for the month of January.) The prior year end of year AADA for Pine Knot Career Institute is 52.75. The current fiscal year AADA for Pine Knot Career Institute is 46.35 – a decrease of 6.4 AADA.

The prior year end of year AADA plus any growth is multiplied by the total state SEEK per pupil amount to get the total revenue generated for the Pine Knot Career Institute. According to the 2014-2015 Tentative SEEK calculation, the total state SEEK per pupil amount of \$5,757; therefore, the total revenue generated for Pine Knot Career Institute is \$303,381.75 (52.75 x \$5,757).

Expense:

The McCreary County Board of Education currently employees the following: three full-time classroom instructors, one part-time special education instructor, and one part-time administrator. The total salary and fringe costs for 2014-2015 are \$267,748.

The McCreary County Board of Education budgets \$2,615 for substitute costs.

The McCreary County Board of Education budgeted \$24,750 for other operating costs including: \$2,500 for general supplies and \$22,250 for the purchase of curriculum software. (Please note: Pine Knot Job Corp reimbursed the school district \$9,000 for the purchase of the software.)

The total expenses for Pine Knot Career Institute are \$295,113.

Profit:

The total profit for the Pine Knot Career Institute is \$8,268.75 plus \$9,000 reimbursement equals \$17,268.75.

It is important to understand the effects of losing the agreement with the Pine Knot Job Corp, too. If the agreement is not renewed for the 2015-2016 school year, then the district will lose all revenue generated by the students at Pine Knot Career Institute, as well as, carry the cost of the tenure staff. The district will potentially lose approximately \$571,129.75.

Please Note: The school district has been tracking the enrollment and communicating with the Pine Knot Job Corp. We anticipate from the communications that the Pine Knot Career Institute enrollment will increase with the potential of being an excess of \$100,000 profit for the 2015-2016 school year (including the cost of transfers to personnel).
